- 17,557 shares were sold at an average price of \$15.28 per share. Sixteen individual trades were executed at prices ranging from \$15.14 per share to \$15.33 per share.
- 16,504 shares were sold at an average price of \$15.2633 per share. Twenty-two individual trades were executed at prices ranging from \$15.13 per share to \$15.33 per share.
