- The sales reported in this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on May 11, 2015. The primary purpose is to provide liquidity to pay off the remaining estate taxes in connection with the estate of Margaret Kelly.
- 25,152 shares were sold at an average price of \$15.2771 per share. Thirty individual trades were executed at prices ranging from \$15.03 per share to \$15.35 per share.
- 20,245 shares were sold at an average price of \$15.3405 per share. Twenty three individual trades were executed at prices ranging from \$15.17 per share to \$15.42 per share.
