- The sales reported in this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on May 11, 2015. The primary purpose is to provide liquidity to pay off the remaining estate taxes in connection with the estate of Margaret Kelly.
- 17,115 shares were sold at an average price of \$15.050 per share. Twenty individual trades were executed at prices ranging from \$14.95 per share to \$15.11 per share.
- 41,413 shares were sold at an average price of \$15.1051 per share. Seventeen individual trades were executed at prices ranging from \$15.01 per share to \$15.17 per share.
